Level: 4 Grades: 11-12 5 Credits/Year

Honors Spanish 5 reviews grammar skills already learned and extends the use of language skills to a more advanced level. Students continue to develop language control, vocabulary, cultural awareness, and communicative strategies in Spanish. Students read authentic literature, write compositions, and engage in sustained discussions based on the reading selections.

Prerequisite: Successful completion of Honors Spanish IV with a final minimum grade of C.
