Course Description and Fundamental Concepts

W21-15 SPANISH A Level: 2 Grades: 9-12

5 Credits/Year

Prerequisite: None

Spanish Basic A is designed for the student who requires small group support as he/she develops novice language skills in the target language. Students work to build novice skills in all modes of communications-interpretive and interpersonal and presentational. Themes are cross-curricular: Personal and Family Life and School and Social Life. This course is designed to meet the world language graduation requirement. It includes some of the major topics of first year Spanish. There will be emphasis on listening comprehension. Students will work in pairs and/or small groups to help them practice new language skills. This course will give the students the opportunity to work with more projects and familiarize them with the culture, traditions and celebrations.

This course is specifically designed to prepare a student for Spanish B; it will not prepare a student for Spanish II or Spanish III.
