#### **Course Description and Fundamental Concepts**

W22-15 SPANISH B Level: 2 Grade: 10-12 5 Credits/Year Spanish B is intended for students who have taken Spanish A or Spanish I at the high school level and who seek one additional year of study to complete the two-year world language requirement for high school graduation. The emphasis of the course will be to continue to develop reading and listening comprehension, vocabulary, and conversational Spanish within the context of Latino and Spanish culture. This course exposes students to a broader understanding of those cultures through projects, DVDs, and other media.

Prerequisite: Successful completion of Spanish A or Spanish I in the high school with a passing grade and teacher recommendation. This course is **not** designed to prepare students for Spanish II or Spanish III.
