Course Description and Fundamental Concepts

This course is designed to meet the world language graduation requirement. This course introduces basic vocabulary and conversational skills centering on common themes such as greetings, likes and dislikes, personal descriptions, time and schedules, and school life. The emphasis is in acquiring proficiency in communicating in Spanish used in daily living situations and travel. The students will also be introduced to customs, traditions, fine arts, cultural diversity and global awareness, which are integral to this course of study. The instruction shall highlight and promote diversity, including economic diversity, equity, inclusion, tolerance, and belonging in connection with gender and sexual orientation, race and ethnicity, disabilities, and religious tolerance; examine the impact that unconscious bias and economic disparities have at both an individual level and on society as a whole; and encourage safe, welcoming, and inclusive environments for all students regardless of race or ethnicity, sexual and gender identities, mental and physical disabilities, and religious beliefs.
