[Course Description and Fundamental Concepts](#)

Latin III Honors presents the declining Republic as seen in the prose writings of Cornelius Nepos, Sallust, and Cicero. The second semester includes a survey of Roman literature of the Gold and Silver Ages, focusing on the poetry of Catullus and Ovid but also looking briefly at writings by Phaedrus, Jerome, and medieval monks and students. Students will review the grammar and vocabulary learned in the first two years and will learn more advanced vocabulary, rhetorical devices, and scansion and meter of poetry in Latin. The SAT II may be taken at the completion of Honors Latin III. Grades 10-12. Prerequisite: Successful completion of Latin II with a final minimum grade of C and teacher recommendation.
