Course Description and Fundamental Concepts

- **W01-25** **FRENCH I CP**
- **Level: 2** **Grades: 9-12** **5 Credits/Year**
- In this college preparatory course, French I students are introduced to the sounds and grammar of the language. By the end of French I, students can speak in short sentences in response to a teacher's question. They understand French spoken at a normal tempo by the teacher and are able to read short paragraphs based on familiar vocabulary and topics. Students write short, simple sentences and describe action using the present, near future, and past tenses. Included in this course are many activities that interest teenagers, such as school, leisure time, and sports.
