[Course Description and Fundamental Concepts](#)

Students learn to prepare, analyze and argue propositions presented in the contexts of model congress, policy debate, mock trial, and international relations. Emphasis is on the techniques of speaking, logic, critical thinking, and reference skills. Students are given the opportunity to participate in the South Jersey Debate League, the National Forensic League, and the Mock Trial Team as well as various Model Congress and Model United Nations competitions.

The course is designed for students looking to enhance expression of thoughts and expand methods of persuasion. Students with political interests will find the course a natural fit, but the course remains relevant to all students pursuing critical thinking skills. Participation in competitive debate extracurricular activities is not required, but consideration should be given. **Prerequisites: Honors Argumentation and Debate III**

Era 2. Revolution and the New Nation (1754–1820s)

The war for independence was the result of growing ideological, political, geographic, economic, and religious tensions resulting from Britain’s centralization policies and practices. The United States Constitution and Bill of Rights were designed to provide a framework for the American system of government, while also protecting individual rights. Debates about individual rights, states’ rights, and federal power shaped the development of the political institutions and practices of the new Republic.

Technological developments and unregulated business practices revolutionized transportation, manufacturing, and consumption, and changed the daily lives of Americans. The Industrial Revolution and immigration had a powerful impact on labor relations, urbanization, the environment, cultural values, and created tensions between ethnic and social groups.

Progressive reform movements promoted government efforts to address problems created by rapid industrialization, immigration, and unfair treatment of women, children, and minority groups. An expanding market for international trade promoted policies that resulted in America emerging as a world power.

Era 11. The Great Depression and World War II: World War II (1929–1945)

The United States participated in World War II as an Allied force to prevent military conquests by Germany, Italy, and Japan. Domestic and military policies during World War II continued to deny equal rights to African Americans, Asian Americans, and women.

The increased economic prosperity and opportunities experienced by many masked growing tensions and disparities experienced by some individuals and groups. Immigration, educational opportunities, and social interaction have led to the growth of a multicultural society with varying values and perspectives.

- Using the case provided annually by the New Jersey State Bar Association, students will break down and develop a court case including opening and closing statements and direct and cross examination of witnesses.
- Students will enact a mock trial.
